5. Clerk and Speaker Fee Rs. 500 ;
6. Auction costs and other payments, if any;

7. Stamp duty on sale certificate.

\* The sale of the property is subject to court approval.

The Balance of 75% (Seventy-five percent) of the purchase price must be deposited to the credit of the case bearing the above number within 30 days from the auction date.
