In terms of the Court Order given dated 11th November year 2020, that due to the failure on the part of the Defendant to effect the full payment of the loan obtained due as agreed, the full balance of the loan to be paid stands at Rupees Five Lakhs Seventy Seven Thousand Twenty One and Cents Twenty Six (Rs. 577,021.26) inclusive of the balance of the loan Rupees Five Lakhs Twenty Seven Thousand Four Hundred Forty Seven and Cents Fifty (Rs. 527,447.50) standing on 31.07.2017 and the Loan Portion Standing unpaid relevant to the installments - Rupees Forty Nine Thousand Five Hundred Seventy Three and Cents Seventy Six (Rs. 49,573.76).
