Administrative Limits of Rajgama Pradeshiya Sabha (Part I)

To the North: From the point bordering the right wall of Udugalpitiya Dream Village Hotel and going to the sea, along the right wall of Dream Village Hotel, along the Galle Colombo Highway, along Good Shed Mawatha to Rathgama Lagoon and from there along the west bank of Rathgama

Lagoon to the field behind the Twenty Acre Temple. With a drawn line,

East: From that point along the paddy field behind Akkaravissa temple to Sirikandura watta gate, from there to Ambagaha Junction on Pinkanda, Gimmellagaha Road, From that Point to Ironwala Canal, from there to waduguda on the western border of Horagampita Canal, then along the remaining part of Horapita Canal where it meets Ging Ganga by a line drawn to the point,
