#### RESOLUTION

For buildings, lands, houses, immovable properties located within the area declared to be a developed area within the area of Pradeshiya Sabha of Nuwaragam Palatha East to accept the said Assessment for the Year 2024 for the Year 2024, under Section 146 Sub-section (1) of the Local Council Act, No. 15 of 1987.

Based on that assessment, me as the Secretary also decide that in accordance with the powers assigned to the Nuwaragam Palatha East Pradeshiya Sabha by Sub-section (1) of Section 134 of the Pradeshiya Sabha Act, No. 15 of 1987, an assessment of 3 Percent (3%) of the aforesaid annual value shall be levied on the said property.

Furthermore, it is further decided that the assessment imposed for the year 2024 shall be paid to the Nuwaragam Palatha East Pradeshiya Sabha Office in Four Equal installements in each quarter ending on 31st March, 30th June, 30th September and 31st December and the total amount for the year 2024 a ten Percent (10%) discount will be given on the total assessment amount if the assessment fees are paid to the East Nuwaragam Provincial Regional Council Office on or before January, 31, 2024 and the assessments for each quarter will be paid on or before the last day of the first month of each quarter. I also decide to give a discount of Five Percent (5%) on each quarter's assessment if paid to the Nuwaragam Palatha East Pradeshiya Sabha.
