05 Duly perfected tender forms should be placed in the sealed envelope on the left - hand corner of which should be clearly marked the "Tender for Foreign Liquor Tavern bearing No..... of Divisional Secretariat of Colombo - 2025" and (a) be deposited in the Tender Box of the Divisional Secretariat - Colombo or be sent to the Divisional Secretary, Colombo so as to reach him on or before **10.30 a.m. on 13.09.2024** Tenderers should be present at the Divisional Secretariat at the time of opening tenders.

06. The successful tenderer should immediately on declared to be the purchaser of the Privilege, pay the Divisional Secretary an amount specified for signing the Sale conditions of privilege as a security deposit, in terms of the Foreign Liquor Tavern Sale conditions.

07.
