Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

To the above – named defendant,

IN terms of the aforementioned Decree dated 20<sup>th</sup> May 2015, in respect of the above Court Case, it has been ordered to pay One Million Five Hundred Sixty – Four Thousand Three Hundred Ninety-Eight Rupees and Ninety Cents (Rs. 1,564,398.90) and interest at the rate of 27% per annum on the principal amount until the said amount is paid in full, and 5% penalty interest on the outstanding installments and other expenses,

In case of inability to pay One Million Five Hundred Sixty-Four Thousand Three Hundred Ninety-Eight Rupees and Ninety cents (Rs. 1,564,398.90) and the interest at the rate of 27% per annum on the principal amount until the said amount is paid in full, and the 5% penalty on the outstanding installments and other expenses, within 2 months from the date of the said Decree or such longer period as the Court may directed in the said Decree, it has ordered that the land and property set out in the Schedule hereto which certified on 07.04.2014 by the Notary Public Jayanka D. Kahawevihana held as a security under the Mortgage Bond No. 1000, be sold at a Public Auction on the terms of sale approved by the Court by an Authorized Auctioneer appointed by the Court,

To authorize the auctioneer to carry out the below directives,

- I. To sell the land set out in the Schedule hereto initially at a valuation price determined by him, in case of non-availability of a bidder for that valuation, then to sell to the next highest bidder, if unavailability of such bidder, then to the valuation price determined by the Court,
- II. To allow the plaintiff or any other person on behalf of the plaintiff to purchase the same premises on such terms as the Court may determine,
- III. To authorize and order the auctioneer or any other office or officers appointed by the Court to make the following productions, re-transfer and to sign the transfer on behalf of the Purchaser by following the terms stipulated for such sale,
- IV. An order permitting the Plaintiff to purchase the property, if the purchaser is a third party, and an order directing him to deposit the respective sum at the Court,
- V. An order by confirming the above sale,

VI. To order the Fiscal Officers of the relevant Province to provide the vacant and uninterrupted occupancy of the land and premises sold above to the Buyers of Purchasers,

Court fee and to grant such other and further relief as the Honorable Court shall seem meet, not specifically requested herein,

Under the execution power vested in me to sell the respective properties by confiscating the same,
