

Salary Advance Bond Form

One Party of hereafter called as "the debtor" (relevant conformed places to the debtor means his heirs, inheritables and Administrators and they are included in it) other party (hereafter mentioned as" that Socialist Republic of Sri Lanka) on behalf of the Democratic Socialist Republic of Sri Lanka the officer who is authorized on him hereby agreed and signed in following days and dates.

The debtor is intended to buy for his personal use as he is requested a loan from the Democratic Socialist Republic of Sri Lanka and agreed as follows.

1. The Democratic Socialist Republic of Sri Lanka is agreed to give a loan facility to the debtor not more than Rs. on day of 20 or before that to buy a

2. The debtor purchased a for Rs. to his own name and made this agreement to prove that he invested the total amount to buy and for the witness of he should forward a relevant receipt to the authorized agent or on day of 20

3. The debtor hereby agreed to pay the total amount of Rs. as installment basis fo Rs. per month with the annual interest rate of Rs. Also, he agreed to pay the first instalment on or before day of 20 for the month of 20.....

4. The debtor hereby authorized to decrease the instalments monthly from his own Salary.

- (a) Till the payment of loan totally completed -
 - (i) That is well maintained without ruinous
 - (ii) When requested by I am ready to forward that and annual permit to an authorized officer or any other officer authorized by him for their investigations.
 - (iii) He is promised to not to do the selling, pawning or assigning to an another party that without a written approval from the secretary of the Ministry.
- (b) Hereby the debtor is abide with responsibility to pay the total amount or a Part of it that scheduled to be paid to the Democratic Socialist Republic of Sri Lanka, If he sold that or pawned or assigned it without a permission of aforementioned secretary of the ministry.

Also, both parties who placed the singnatures for this agreement hereby agreed with each other on their wish.

- 1. There is no change of the responsibility which was given to that the debtor is abide to pay the whole loan amount to the Democratic Socialist Republic of Sri Lanka, although he faced for an accident, lost or damaged it.

2. Though, whatever mentioned in this agreement

- (i) If the debtor has to resign the government service; or
- (ii) If the debtor died; or
- (iii) If the debtor violate the terms of the agreement in somehow; or

The debtor should pay the total loan amount or a part of it immediately to the government.
