All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* notices for publication in the weekly *Gazette* of 09th January, 2015 should reach Government Press on or before 12.00 noon on 26th December, 2014.

**Report of the Auditor General on the Financial Statements of the University of Jaffna for the Year ended
31st December, 2012 in terms of Section 108 (2) of the Universities Act, No. 16 of 1978**

THE audit of Financial Statements of the University of Jaffna Sri Lanka for the year ended 31st December, 2012 and the statement of financial position as at 31st December, 2012 and the Statement of comprehensive income, statement of changes in net assets and cash flow

statement for the year then ended and a summary of significant accounting policies and other explanatory information, was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sub Sections 107 (5) of the Universities Act, No. 16 of 1978. My comments and observations which I consider should be published with the annual report of the University in terms of Sub Section 108 (1) of the Universities Act appear in this report. A detailed report in terms of Sub Section 108 (2) of the Universities Act appear in this report. A detailed report in terms of Sub Section 108 (2) of the Universities Act, No. 16 of 1978 was issued to the Vice Chancellor of the University on 31st October, 2013.

1:2 *Management Responsibility for the Financial Statements :*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

1:3 *Auditor's Responsibility :*

My responsibility is to express an opinion on these financial statements based on conducting the audit in accordance with Sri Lanka Auditing Standards. Because of the matters described in the Basis for Disclaimer of Opinion paragraph, However I was not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion.

1.4 *Basis for Disclaimer of Opinion*

As a result of matters described in paragraph 2.2.3 of this report I am unable to determine whether any adjustments might have been found necessary in respect of recorded or unrecorded items and the elements making up the statement of financial position, statement of comprehensive income, statement of changes in net assets and cash flow statement.

2. Financial Statements :

2:1 *Disclaimer of Opinion :*

Beause of the signifiacne of the matters described in paragraph 2.2.3 of this report, I have not been able to obtain sufficient appropriate audit evidence to provide a basis for an opinion. Accordingly, I do not express an opinion on these financial statements.

2:2 *Comments on Financial Statements :*

2:2:1 *Accounting Deficiencies :*

Following accounting deficiencies were observed in audit.

- (a) Value of books and periodicals amounting to Rs. 2,191,072 and 87 items of journals and periodicals to the value of Rs. 1,359,072 in respect of the years 2005, 2006, 2007, 2008 and 2009 shown in the financial statements had not been received from the suppliers up to 30th June, 2013. However, the depreciation of those books and periodicals amounting to Rs. 438,214 had been charged against income.
- (b) Building works for Rs. 1,708,750 had been completed and handed over to the University by the Department of Buildings. However, it had not been capitalized due to the non-submission of work completion certificate by the Department of Buildings.
- (c) Expenditure over income amounting to Rs. 1,202,957,271 had been erroneously debited to the General Reserve account instead of being charged to the Accumulated Fund. As a result an unusual debit balance had been shown in the General Reserves as at 31st December, 2012.
- (d) Out of rent receivable amounting to Rs. 55,050 from several staff members of the University, a sum of Rs. 27,250 had not been recovered from the staff during the year under review.
- (e) Even though the interest amounting to Rs. 3,791,274 had been disclosed as receivable from endowment fund, the amount had been credited to the Restricted fund account instead of charging to the investment income account for the year under review.
- (f) A sum of Rs. 364,569 had been shown as Suspense Account as at 31st December, 2012 and out of this a sum of Rs. 103,410 had been remained for over Six years without being taken action to clear those balances.

- (g) Several corrections were made in the salary advance account and import advance account aggregating Rs. 993,456 without making proper Journal entries during the year under review.
- (h) Although Six numbers of Payment Vouchers aggregating Rs. 705,500 had been forged due to the purchase of Library books and periodicals in December, 2012, immediate action had not been taken on this fraudulent transaction and had been erroneously debited to Books and Periodicals account.

2:2:2 *Accounts Receivable and Payable :*

Following observations are made.

- (a) No provision for doubtful debts had been made in the financial statements in respect of outstanding balances amounting to Rs. 504,237 for more than five years.
- (b) Trade payables included the outstanding balance for more than five years amounted to Rs. 2,562,402.
- (c) Unpaid salaries amounting to Rs. 1,080,499 to the Staff of the University remained as payables for the period ranging from 01 - 02 years without being taken action in terms of FR. 272 (2), and FR. 290.
- (d) Advances made to the various parties such as Department of Buildings, Ceylon Electricity Board, Staff of the University and suppliers to import the books and periodicals and salary aggregating Rs. 311,866,788 had not been recovered up to 30th June, 2013. Out of this, a sum of Rs. 3,810,882 had not been recovered for more than 10 years.
- (e) Distress loan balance of Rs. 53,055 receivable from one staff and Motor cycle loan balance of Rs. 10,802 receivable from another staff had been outstanding for last 09 years and 11 years respectively without being taken action to recover.

2:2:3 *Lack of Evidence for Audit*

Following observations are made :

- (a) The value of Property, Plant and Equipment aggregating Rs. 1,160,054,959 shown in the financial statements had been based on book value. However a physical verification of these assets had not been carried out during the year under review. Further a detailed schedule of a fixed assets and a register pertaining to fixed assets had not been maintained property or provided for audit. Therefore, the existence, accuracy and completeness of the assets shown in the financial statements could not be ascertained in audit.
- (b) Items in the accounts such as inventory items, travelling claims, allowances, rent payments, telecommunication charges, repairs to vehicles and payment for cleaning service aggregating Rs. 36,402,416 could not be satisfactorily vouched or accepted in audit in the absence of evidence or collaborative evidences such as annual verification reports, advance programmes and authority, telephone register, vehicle examiner's reports and vehicle log books etc.
- (c) Items such as donations, losses and damages incurred on vehicle accidents, research allowances and payments for the academic programmes etc. could not be satisfactorily vouched or accepted in audit due to non-rendition of following evidence or collaborative evidences.
- Detailed reports on donations received from foreign countries/embassies.
 - Minutes of the University Senate.
 - Reports on accidents and losses
 - Details of academic programmes of Faculty of Management Studies.
 - details of research of the academic staff.

3. Financial and Operating Review

3.1 Financial Review :

3.1.1 Financial Results :

According to the financial Statements presented, the working of the University for the year ended 31st December, 2012 had resulted in a deficit of Rs. 100,783,982 as compared with the corresponding deficit of Rs. 60,290,341 for the preceding year, thus indicating a further deterioration of Rs. 40,493,641 in the financial results of the University due to increases in personal emoluments, contractual services, depreciation and amortization expenses.

3.1.2 Uneconomic Transactions :

Following observations are made.

- (a) Telephone Intercom facilities had been installed at the University in January, 2011 in order to reduce the official telephone charges by reducing the use of existing direct telephone lines. However, the telecommunication charges for the year under review had been increased by Rs. 2,635,377 or 20 percent when compared with the charges for the preceeding year due to the outgoing facilities had also been facilitated through the intercom lines simultaneously.
- (b) The University Registrar and Deputy Registrar (Capital works) had been occupying in a guest house since April 2009 and November, 2010 respectively without paying rent. In this connection, electricity charges aggregating Rs. 37,262 had been paid from the University funds.
- (c) Sum of Rs. 242,263,073 and Rs. 132,618,288 had been invested and shown as Long Term and Short term Investments respectively in the financial statements for the year under review. However a sum of Rs. 4,497 only had been charged to the account as the income from an investment which was 0.001 percent of the total investments. Thus indicating that the University funds had not been utilized efficiently and effectively to earn maximum benefits.

3.1.3 Assets Management:

Following observations are made.

- (i) The following vehicles had remained idle. However, no meaningful action had been taken to utilize these vehicles for the intended purpose of the University.

- (ii) Supplies and maintenance items aggregating to Rs. 4,107,424 had remained unused for a period ranging from 01 to 14 years in the stores of the University. In this regard no action had been taken to utilize them.
- (iii) A time recording machine purchased for Rs. 182,400 had been remained unused since 2001.
- (iv) Hundred and Fifty-six steel beds purchased for Rs. 1,482,000 had been remained unused for over six years.
- (v) Hundred and Sixty-one computers and accessories, multimedia project equipments and furnitures had been identified as idling and under utilized assets in the office of the Dean, faculty of Management Studies and Commerce, Department of Human Resources, Department of Accountancy and in the Department of Physics.
- (vi) Nine Hundred and Seventy items received under the SIDA project were brought by the Two private customers for the assembling of LAN/WAN connections at the University had been allowed to idle in the Department of Computer Science for more than two years.
- (vii) It was observed that 223 damaged items were lying idle in the Department of Computer Science for more than one year and action had not been taken thereon in items of F. R. 110.

- (viii) Thirty-seven sports equipment had been disposed off by the Coordinator of the sports science unit in 2008, 2009, 2010 and 2012 without obtaining the required approval.

3.1.4 *Items of Contentions Nature :*

Following observations are made.

- (i) Even though the buildings, resource persons and all other facilities had been made available at the University, the lectures for the 4th year students of the Department of Law were being conducted in a building taken on rent basis in Colombo since March 2008 and paid a sum of Rs. 5,430,000 as rentals at the rate of Rs. 100,000 per month up to 31st December, 2012.
- (ii) Even though it had been planned to install the finger print scanner progressively in early part of 2011, it had not been effectively installed for the intended purpose in terms of Establishment Circular No. 02/2010 of 15th February, 2010 issued by the University Grants Commission.
- (iii) Twenty-two numbers of cheques valued at Rs. 8,593,446 had been drawn on 15th October, 2012 and issued to 14th organizations as advances for the purchase of equipments; subsequently those cheques had been cancelled on 12th February, 2013.

3:2 **Operating Review**

3.2.1 *Verification of Physical Existence of Tangible Assets :*

Report of the Annual Board of survey on physical verification of fixed assets and other inventory articles for the year 2012 had not been carried out and rendered the report for audit in terms of Sections 2, 4 and 5 of Chapter XXVI and Section 3.1 of Chapter XXIV of the Establishments Code of the University Grants Commission and Higher Educational Institutions and F.R. 756.

3.2.2 *Examinations and Results :*

Dates to hold the examinations for various courses conducted under each faculty of the University and target dates to release results of the examinations had not been determined. It was further observed that there were considerable delays in releasing the results of examinations conducted by the faculties of Agriculture, Arts, Management Studies and Commerce, Science and External Examination unit of the University during the years 2011 and 2012. According to the University Grants Commission Circular No. 636 of 14th July, 1995 results should be released within three months after the examination. But, results had been delayed for periods ranging from 4 to 14 months; thereby the students had been deprived to get their employment opportunities in time.

3.2.3 *Cost per Student :*

Total number of students registered for the courses of the University was 5,896 as at the end of the year under review. The total recurrent expenditure incurred during the year under review amounted to Rs. 644,212,414. The average recurrent cost per student for the year was Rs. 109,263.

3.2.4 *Human Resources Management :*

Following observations are made.

- (a) The University had not taken action to retrench the existing vacant cadre; instead the staff had been recruited on temporary basis excessively. Details are as follows:

- (b) Attendance register for the Academic staff had not been maintained for a long period. Therefore, the leave, accuracy of the salary payment made to the staff for the year under review could not be satisfactorily vouched in audit for the year under review.

3.2.5 *Recruitments and Appointments :*

Following observations are made.

- (a) The University Council had decided to forward the decision to reinstate the staff by considering the appeals from various parties based on sympathetic grounds without considering the provision laid down in paragraph 20:16 of Chapter III of the Establishments Code of the University Grants Commission and Higher Educational Institutions and the letter No. UGC/HR/3/1/6 dated on 28th September, 2012 forwarded by the Chairman of the University Grants Commission.
- (b) The Secretary of the University Grants Commission had informed by his letter No. UGC/HR/1 dated 10th December, 2004 to the Vice-Chancellor of the University of Jaffna that the Higher Educational Institution has the authority to confirmed the services of the Senior Assistant Registrars, Assistant Registrars and other similar posts. However, the following observations are made on the confirmation of service of the staff.
- (i) Different number of members had been appointed for the different panels for the oral test.
- (ii) Proper method in appointing/selecting the members of the panel had not been adopted to verify the performance of non-academic staff as requested by the paragraph No. 06 of the letters of appointment.

3.2.6 *Procurement of Goods and Services–*

Following observations are made–

- (a) According to Guideline 4.2.1 of the Procurement Manual, a detailed procurement plan had not been prepared.
- (b) Although according to Guideline 4.2.1 (b) of the Procurement Guide lines, the Procurement activities envisaged at least for a period of three years should be listed in the Master Procurement Plan, the University had listed the procurement activities only for the year under review.
- (c) Target dates of completion for the items mentioned from No. 07 to No. 13 of the Master Procurement Plan had not been indicated.
- (d) Master Procurement Plan had not been approved by the Secretary to the Ministry of Higher Education.
- (e) According to Guideline 4.2.2 of the Procurement Guidelines, a procurement time Schedule should be prepared by describing in chronological order, steps of each individual procurement action from the point of commencement and until its completion. However, the time Schedule and steps of each individual procurement action had not been prepared by the University.

4. Accountability and Good Governance

4.1 *Corporate Plan :*

Although the Corporate Plan for the period 2012- 2016 had been prepared, it had not been periodically reviewed in terms of Public Enterprises circular No. PED/12 of 02nd June, 2003.

4.2 *Annual Action Plan :*

An Action Plan for the years 2012-2016 had been prepared instead of for the Year 2012. However, the progress on the targets indicated in the action plan had not been achieved.

4.3 Internal Audit :

Following areas of transactions were not examined/covered by the internal audit unit as per the internal audit programme for the year under review.

- (a) Post Audit on Capital Projects and Contract Management.
- (b) Procurement Works of the University.
- (c) Debtors and Creditors Management.
- (d) Loans and Advances.

4.4 Follow up Action on Audit Queries :

Following observations are made.

- (a) The management of the University had not aware of the details and number of audit queries issued in each financial years as the certain queries had been misplaced and requested a copy again after considerable period of time.
- (b) Even though the copies of the audit queries had been forwarded to the University Grants Commission, the Vice Chancellor of the University had not forwarded the copies of the replies to those audit queries to the University Grants Commission.
- (c) Details of the unanswered audit queries are given below.

Annual Report for the Year 2011 had not been tabled in Parliament even up to 20th October, 2013 in terms of Section 6.5.3 of the Public Enterprises Circular No. PED/12 of 02nd June, 2003.

4.6 Budgetary Control :

Significant variations were observed between the budget and actual, thus indicating that the budget had not been made use of as an effective instrument of management control.

Deficiencies observed in systems and controls during the course of audit were brought to the notice of the Vice- Chancellor of the University from time to time. Special attention is needed in respect of the following areas of control.

- (a) Assets Management ;
- (b) Library administration ;

- (e) Delays in Projects ;
- (f) Receivables and Payables ;
- (g) Procurements ;
- (h) Human Resources Management ;
- (i) Budget.

3.1.2

- (a) Due to prevailing normalcy in the area, the academic and administrative activities of the University have been expanded and increased providing latest communication facilities which cause for this increase in the usage. Due to the development activities, widening of road network caused frequent disconnection of power supply during the whole office hours leads to the compulsory usage of direct lines.
- (b) It is to be pointed out that electricity charges for the nine months aggregating to Rs. 26,253.26 has an average monthly sum of Rs. 2,917.029 and the average monthly charge for this should have been much lower than this if the first three months are not taken into account. During December to April in the above Building Engineers and workers who work under SIDA project for the It network project stayed there and completed and finalized all the work. University has signed the agreement with SIDA in which it was agreed to provide accommodation and electricity and other amenities free for those who were engaged by way of SIDA agreement to facilitate completion of the said project. They used electrical equipment during the stay and it was the reason for the higher electricity charges during that period. Further, CEB has reported connection wiring malfunctions during the period in the line supplying electricity to the said building and losses have been reported to be occurred to faulty earthing in the surroundings. This fact could be verified from the CEB as it has rectified it later after informing the University. Only the basic electrical maintenance charges are to be expected from the Guest House and no special/extraneous expenses were related to it. The Registrar by virtue of his post is entitled for quarters and was accommodated in the above said premises with the approval of the Vice Chancellor.
- (c) Whatever interest earned from investment out of the endowment fund or similar donation would be utilized for the intended purpose of the donor.

3.1.3

- (i & ii) With the Shifting of the Faculty of Agriculture to Kilinochchi the Land Master will be used. Action will be taken to auction for other vehicles.

The items in the stores are being classified into serviceable and obsolete items. Action has already been taken in the year 2013 to auction all the obsolete items.

- (iii) Already finger scanner machines were installed and in use according to the latest Circular. Time recording machine. had been taken as condemned and unserviceable item. The procedure to abandon above.
- (iv) All the beds have been already issued to the newly rented houses. No beds are idling.

- (v) With the commencement of the E-Iab of Faculty of Commerce and Management Studies, computers are being used. All these are coming under the Faculty of Commerce and Management Studies.
- (vi) These items are not issued to the Department of Computer Science. These items are left behind by the ETPL Company Ltd. Which constructed the SIDA funded campus LAN WAN Network. to be used in case of a repair. Some items are excess items by the DMS electronic limited who have supplied and installed the network switches.

Computer Unit has a list of these items and it is reported to the Computer Unit for further actions. Action is in progress.

- (vii) All of these items are reported to the Administration Branch for further action after the annual survey held on 17th June, 2013. Now action is in progress.
- (viii) Disposal of damage Items

As there was no space to keep the damaged sports items consumables with the permission of the coordinator we have disposed the items and we assure in case of disposing the damaged items we will obtain permission in future from the Board in-Charge for it.

3.1.4

- (i) It was decided by the University Senate to conduct the 4th year study programme for the LLB students in Colombo in consideration of the following to ensure the quality.
- (1) The fourth year programme consists of six Course Units and Research Project having 30 Credit Value.
 - (2) Only one permanent Lecturer will be available in the Department of Law in the next academic year to undertake the teaching programme.
 - (3) Mr. V. T. Thamilmaran SL I, Mrs. S. Segarajasingam SL I, Mr. Sivapatham SL I and Mr. A. Sarveswaran SL I, of the Faculty of Law, University of Colombo are prepared to take Lectures for the 4th year students in Colombo Center of the Department of Law, University of Jaffna. They cited that present workload and the inconvenience in travelling to and from Jaffna as primary reasons for them to prefer teaching the 4th year students in Colombo.
- (ii) Finger Scanner Machines have been fixed at the all Dean's office, Teaching Hospitals, Library, Registrar's office, Security department, Ramanathan Academy of Fine Arts and Unit of Siddha Medicine to confirm the arrival and departure. Administrative Officers, Trainees and other staff on assignment basis are using the machines. The new recruits and they who will obtain promotion have been issued Letters to use the details with finger scanner.
- (iii) The Cheques were drawn as at 30.12.2012 in order to utilise the availability of funds. The cheques were drawn when the orders were placed. As the supplier did not supply the item within the stipulated period, the cheques were cancelled to reverse the advance.

3.2.1 Already Annual Verification has been done except Library.

3.2.2 Now it has been improved. Action is being taken to report to the Senate about the Examiners who are not responding in time based on the circulars. Further these reminders will be filed in their personal files.

- (a) (i) The Cadre and the actual staff position as at 31.12.2012, excluding the Vavuniya Campus is given below:

As per the above detail, no staff had been recruited excessively as at 31.12.2012. However, during the year 2012, 146 temporary academic staff had been appointed whereas 66 temporary staff had resigned their position or been terminated from the services. Further, six advertisements were made to fill the academic positions in the year 2012 and another two advertisements were made in the month of December 2011 to fill such vacancies. The University had made following numbers of permanent recruitment to the academic grades in the year 2011, 2012 and 2013 to date.

2012	- 29
2013 to date	- 22

The above details clearly reveal that the University of Jaffna has taken all efforts to fill its existing academic vacant positions promptly. Even though the efforts taken by the administration as described above to fill vacancies, the University was unable to fill the 33 positions of Professor Chair as there was no application received with required qualifications despite of repeated advertisements. Such situation is prevailed even for the position of Senior Lecturer/ Lecturer in some disciplines in the Faculty of Medicine. In such circumstances the University filled these vacant positions by Temporary Lecturers, Temporary Instructors or by Temporary Demonstrators in order to carry out the academic programmes without interruption.

- (ii) Out of forum approved academic cadre of the Sports Science Unit, three were filled and action is being taken to fill other vacant position. It is compulsory to the existing two Lecturers (prob.) to acquire necessary postgraduate qualification within the maximum. probationary period of eight years; otherwise, they will be terminated from the services in terms of section 72 of Universities Act, No.16 of 1978 amended by Universities Act, No.7 of 1985 and 1 of 1995. Further both of them were awarded HETC scholarship and NCAS funding for postgraduate studies in the year 2011 and their eight probationary period will expire in June 2014. Having considered the above and the fact that there was another Senior Lecturer in services, the University Council granted study leave to these Probationary Lecturers to complete their Ph.D. programme within June 2014. But, unfortunately the Senior Lecturer in Sports Science went on maternity leave with pay and then on No pay maternity leave. Therefore, the University was forced to carry out the academic programme of Sports Science Unit with Temporary and Visiting appointments.
- (b) Academic Staff in the University system do not generally sign in the Attendance Register. However this matter was brought to the notice at its 372th Meeting of the Council dated 29.09.2012 and it was pointed out at the meeting that nowhere in the world academic staff are expected to sign in the Attendance Register and no action should be taken in this regard. Deans of Faculties endorsed this view. A decision is awaited to implement the finger scanner to record attendance of all other staff. Moreover, Executive officers, staff recruited on temporary/contract/casual/assignment basis and trainees have now been using the finger scanner machine to record their attendance and it is emphasized to extend this to other non-academic Staff as well who will be appointed in near future.

3.2.5

- (a) The Appointment/Reinstatement of the two staff that was made in concurrence with the decision of the UGC by its Letter No. UGC/HR/3/UJF dated 27.02.2013.
- (b) Members are appointed in accordance with the regulations in respect of the posts for which the oral tests were conducted. As such, depending on the posts and level of competencies that each post requires the composition of members may differ, but were constituted in consistence with the scheme of recruitment.

No specific constitution for members for selection boards was in the universities Act or Regulations. Panel for the members for conformation of services is appointed by the head of the institution (Vice Chancellor) if there is no specific scheme given in the scheme of Recruitment in terms of provisions in scheme of recruitment and UGC guidelines where it is stated on the composition of the selection Boards that:

For the Administration Officers the Chairman is the Vice Chancellor

For other Non-Academic staff Registrar is the Chairman.

Two permanent staff are as other members.
