### NOTIFICATION MADE UNDER STATE LAND REGULATION No.21 (2)

IT is hereby notified that for the Purpose of Laying Waste Water Pipeline, The National Water Supply and Drainage Board has requested on lease a state land containing in extent about 0.0240 Hec. Forming a portion of Lot No. 243 as depicted in the Cadastral Map No. 521003 and situated in the village of Ratmalana which belongs to the Grama Niladhari Division of No. 546 C, Ratmalana East coming within the area of authority of Ratmalana Divisional Secretariat in the District of Colombo.

02. Given below are the boundaries of the land requested :

On the North by : Proceeding Way ;	} According to the Cadastral Map
On the East by : Lot No. 243 ;	
On the South by : Bangalawa Road ;	
On the West by : Lot No. 244 .	

The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions and the following Conditions :-

(a) *Term of the Lease.*- Thirty Years (30), ( From 10.12.2014 on wards);

*The Annual Rent of the Lease.*- 4% of the Undeveloped value of the land as per valuation of the Chief Valuer for the year 2014. This amount of the lease must be quinquennially revised in such a manner that the amount as a result of the revision will be not less than 50% of the amount that just preceded.

- Premium* - Three times of the annual amount of the lease;
- (b) The lessee must not use this land for any purpose other than Commercial Purpose (Laying Waste Water Pipeline);
- (c) This lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;
- (d) The lessee must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary and by other institutions ;
- (e) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;
- (f) Permission will not be given for other sub - leasing or vesting except for vesting within the sub leasing or vesting for the purpose for which the land was obtained until expiry of 05 years from 10.12.2014 ;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
