Resolution

IN terms of the powers vested in the Nuwaragam Palatha Central Pradeshiya Sabha under Section 146, Sub-section (1) of the Pradeshiya Sabha Act, No. 15 of 1987, the areas developed within the jurisdiction of the Pradeshiya Sabha under *Gazette No. 2243* of the Democratic Socialist Republic of Sri Lanka and dated 27th of August, 2021 to accept the assessment tax for the year 2024 as the assessment for the year 2024 for the annual value of the houses, buildings, lands, house- lands and immovable properties located within the declared area,

Based on the properties, an annual assessment tax of five percent (5%) of the aforesaid annual value shall be levied on the said property in accordance with the powers vested in the Central Nuwaragam Palatha Pradeshiya Sabha under Sub-section (1) of section 134 of the Pradeshiya Sabha Act, No. 15 of 1987. Therefore, I decide to be the Secretary of the Central Nuwaragam Palatha Pradeshiya Sabha, exercising the powers and performing the duties.

Furthermore, under the provisions of Sub-section (6) of Section 134 of the Pradeshiya Sabha Act, No. 15 of 1987, that assessment enacted for the year 2024, each year ending on the 31st of March, 30th of June, 30th of September and 31st of December of the year 2024 that the full assessment tax for the year 2024 be paid to the Nuwaragam Palatha Central Pradeshiya Sabha office in four equal instalments before the end of the quarter and under the provisions of Sub-section (7) of section 134 of the Pradeshiya Sabah Act, No. 15 of 1987 on or before 31st day of January 2024 a discount of ten percent (10%) of the total assessment tax if paid to the Nuwaragam Palatha Central Pradeshiya Sabha Office in advance, provided that the assessment for each quarter is paid to the Nuwaragam Palatha Central Pradeshiya Sabha Office on or before the last day of the first month of each quarter that I decide to give a discount on the amount of assessment tax (5%) per quarter.
