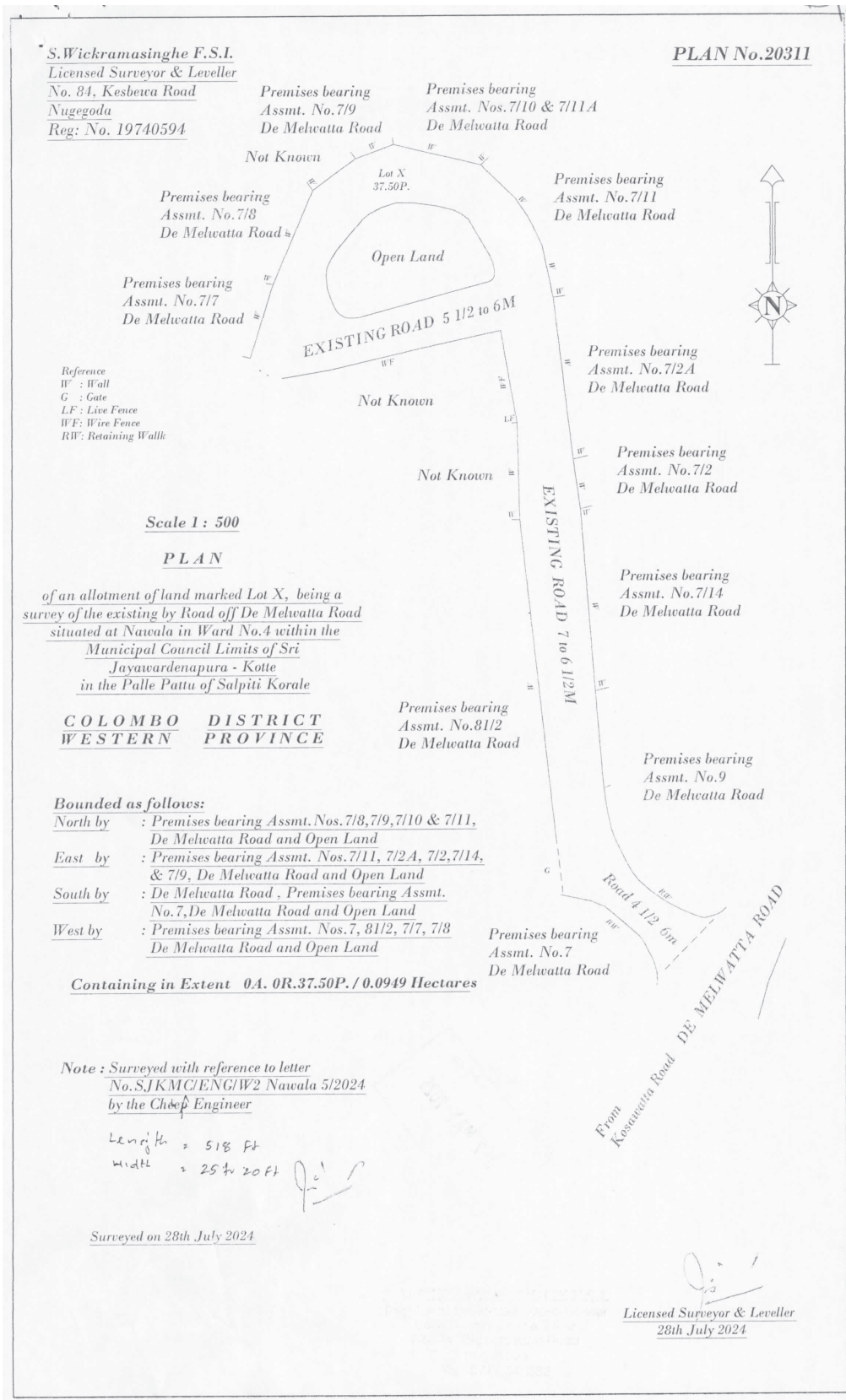


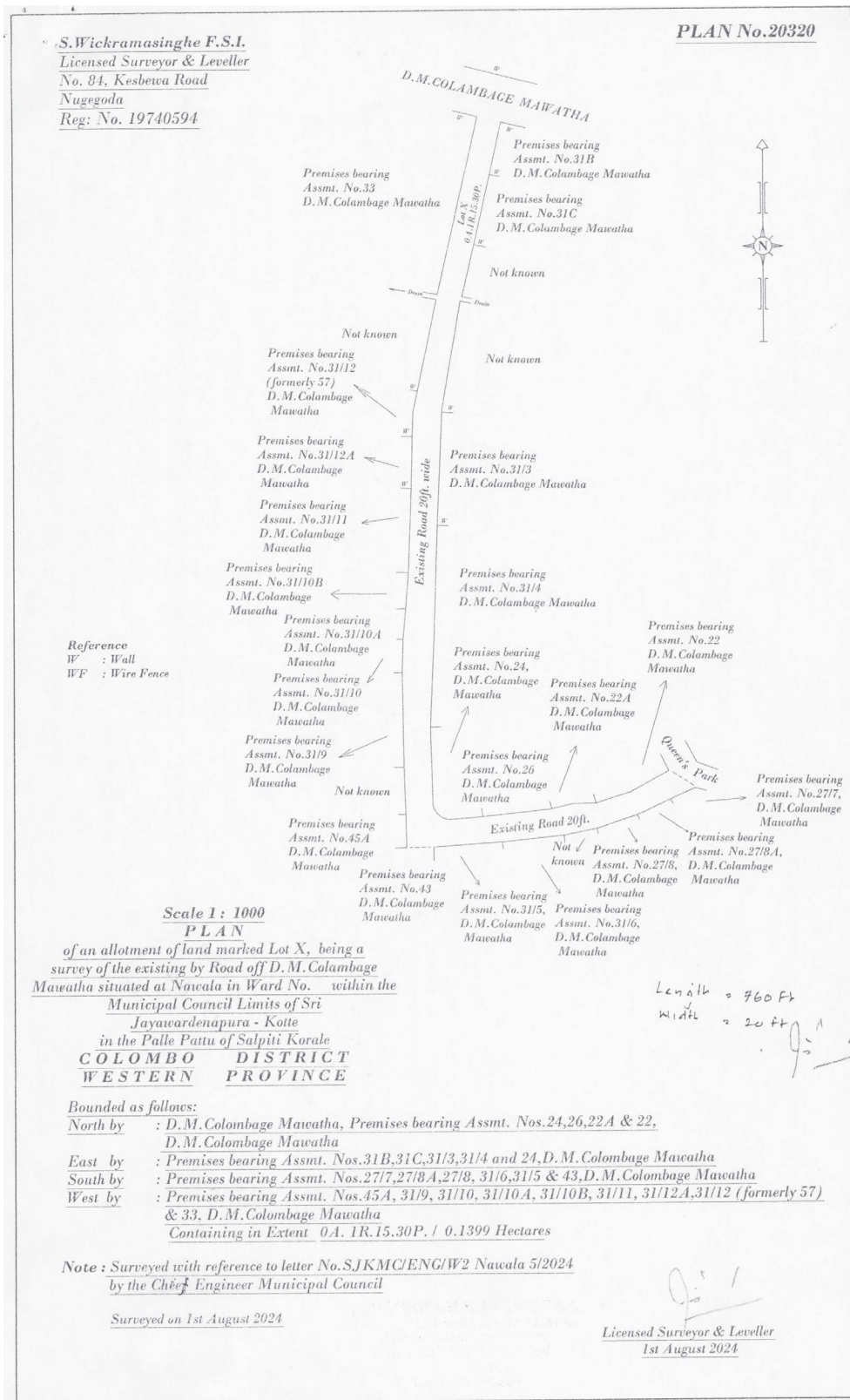












**IMPORTANT NOTICE REGARDING PUBLICATION OF GAZETTE**
