LAND COMMISSIONER GENERAL'S DEPARTMENT

Notification under State Land Regulation No. 21 (2)

IT is hereby noticed that Mrs. R. P. Monica Roshani Jayasinghe has requested the State land allotment in extent 01 acre depicted as Lot No. 01 in the Plan/tracing No. F. V. P. 567 and situated in No. 71, Agunochchiya Grama Niladhari Division which belongs to Medawachchiya Divisional Secretary's Division in the Anuradhapura District of North Central Province on lease for Commercial purposes.

02. The boundaries of the land requested are given below:

On the North by : By Road Reservation;
On the East by : State Land;
On the South by : State Land;
On the West by : State Land.

03. The requested land can be granted lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions and the following conditions :-

(a) *Term of lease* : Thirty (30) years (From the date on which the Hon. Minister grants approval):

Annual amount of the lease.- In the instances where the valuation of land in the year the Hon. Minister grants approval is less than five million rupees (Rs. 5,000,000), 2% of the market value of the land in the said year, as per the valuation of the Chief Valuer. In the instances where the valuation of land in the year the Hon. Minister grants approval is five million rupees or more than five million rupees (Rs. 5,000,000), 4% of the market value of the land in the said year, as per the valuation of the Chief Valuer. This amount of the lease must be revised in every five years and the revision shall be added a 20% of the amount that just preceded;

Premium : Not levied;

- (b) The lessees must, within a period of one year from the date of commencement of the lease, develop the said land to the satisfaction of the Provincial Land Commissioner/Deputy Land Commissioner/ Divisional Secretary;
- (c) The lessees must not use the said land for any purpose other than an Commercial purpose;
- (d) This lease shall also be subject to other special conditions imposed by the Divisional Secretary and other institutes;
- (e) Existing/constructed buildings must be maintained in a proper state of repair;
- (f) If the lessee fails to substantiate the purpose for which the land was obtained within the specified period of time, steps will be taken to cancel the agreement of lease;
- (g) No permission will be granted until expiry of 05 years from the date on which the Hon. Minister grants approval for any subleasing or assigning;
- (h) Payment of the lease rental must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse. In case of Non - payment of lease, a penalty interest of 10% will be charged on the lease in arrears.

If acceptable reasons are not submitted to me in writing within 06 weeks of herein *Gazette* publication to the effect that this land must not be given on lease, the land shall be leased out as requested.
